DESCRIPTION

It may seem obvious to state that religion had a central impact on the articulation of medieval societies in all their dimensions. However, we sometimes underestimate or overlook the impact it had in some fields, such as justice. Christianity and Islam, but also Judaism, gave their own particularities to the different notions of justice that arose in the different political realities of the Mediterranean during the Middle Ages.

The main aim of this conference will be to analyse the different theoretical perceptions that developed around the notion of justice in the Mediterranean between 500-1200. To this end, a number of case studies have been selected from diverse thematic, chronological, geographical and cultural backgrounds. A comparative and intercultural analysis of justice in the first centuries of the Middle Ages will also allow to see the margins of transculturality, i.e. of mutual influence, between cultural spheres that are, a priori, very different.
