Provides technical/program expertise to community coalitions and groups and coordinates collaborative prevention and PES efforts. Secure funding for programs, including developing grant applications and implementing and coordinating grant activities. Create, produce and communicate community health assessment and community health improvement plans and all applicable reporting. Specifics depend on area of assignment.

- Organize and/or participate in local, regional, state coalitions to engage diverse participants as advisors and partners in planning, conducting or advancing PES strategies.
- Create print material, online communications, visual displays and audio-visual pieces to strategically raise awareness and further community organizing and PES efforts.

- Develop, apply for, monitor and submit reporting for grants, other funding sources, and related contracts.
